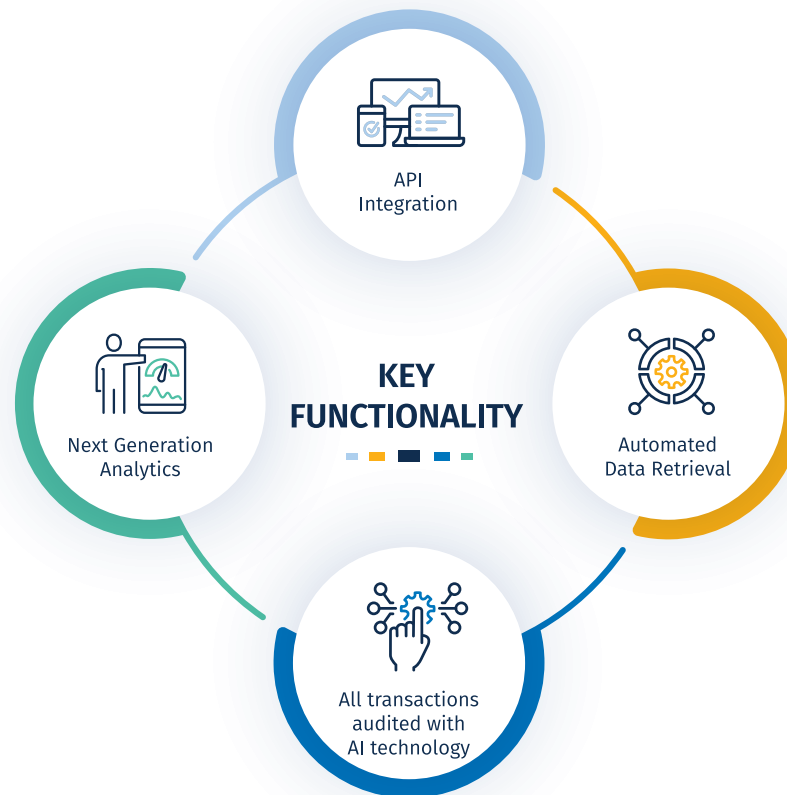
FOREIGN & DOMESTIC VAT RECLAIM

Domestic VAT

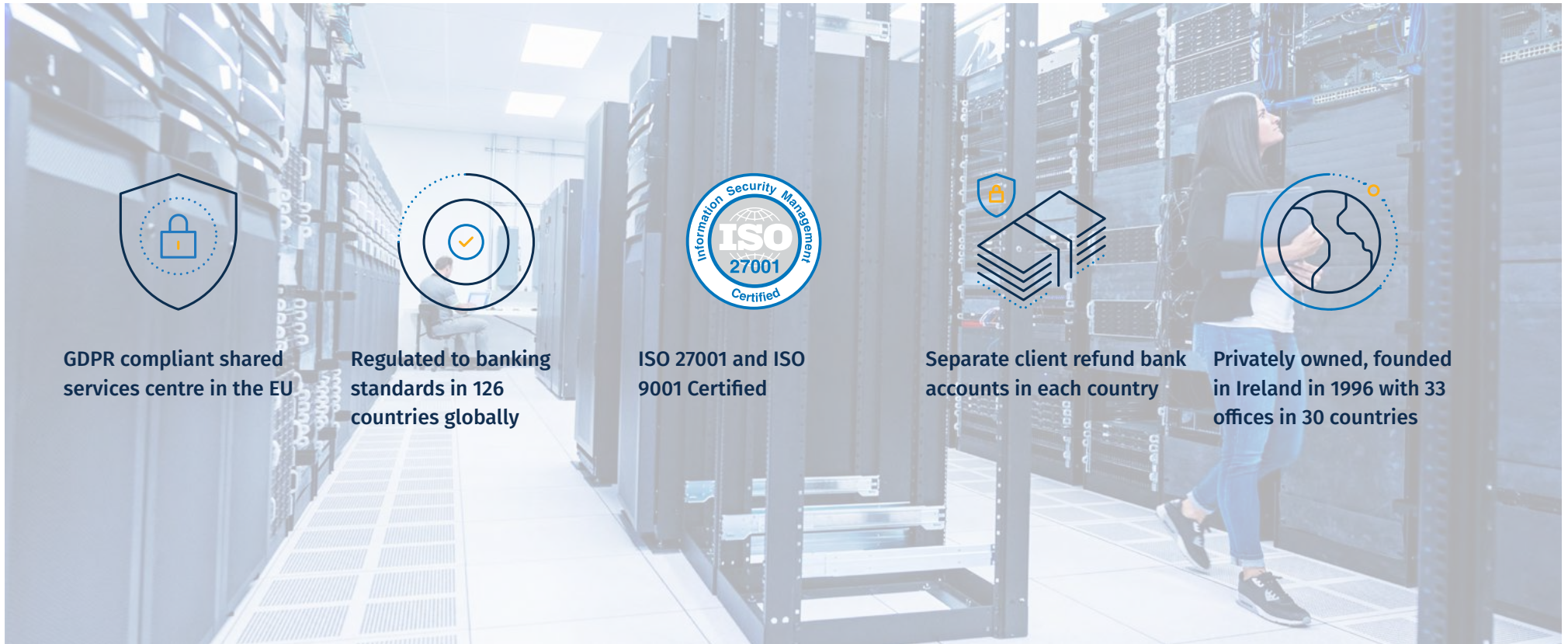
